


About the App

URJA is a mobile application, developed for TATA AIA's SME Business customers. This solution offers quick digital insurance assistance right at their fingerprints.





About the Platform

URJA Web portal acts as a product recommendation engine for the HDFC Bank users providing them customized products based on the user input. This tool is independent of login.



The workflow

User puts basic information (name, email id , phone number, organization type & HDFC bank's branch name)

Based on the input, a customized product is recommended to the user.

Customer chooses the product and requests a call back option.

The lead is generated in the system and the customer receives a call from the TATA AIA team.

Strategic Calls

Multi-Server approach

For smarter handling of high-load CPUs, multi-server approach is followed. Development team receives a notification alert in such scenarios. Using a load balancer, traffic gets distributed equally among the servers.

CMS-Based content

For saving additional effort and time, content delivery has been made configurable not hardcoded. There won't be any development required to change the content, instead it could be updated through CMS (content management system), in real-time.

Hybrid Platform

Since TATA AIA website was developed on AEM(Adobe Experience Manager), Urja Web platform works on both React JS and AEM.
